The wall nearby these presents thatSamson White of Baslow carpenter being Executor to Samuel White senior his ffather who was Executor to Samuel White Junior his son deceased and haveing received the sum of 2 pounds and ten shillings left by Samuel white Junior and ten shillings left by Samuel White Senior as may and doth appeare by their last wills and testaments for the relief of the most needfull poor persons in Baslow and Bubnell, I do hear by promise for myself my heires and successors that when a convenient purchase of land can be had and obtained for this and such other such sums of money as are already or may hereafter be left for the relief of the poor and bennifett of the schooll then I do promise that the said three pounds shall be paid for and towards the same use, and in the meane time I do promiss for and in consideration of the said moneys to pay yearly so long as I or my successors shall hold the same the sum of three shillings and seaven pence...... the 24th day of December according to the true intent and meaning of the wills aforesaid and also having (regd?) two pounds and ten shillings left by the said Samuel White Junior to the schooll in Baslow for and towards the education of some poor children in Baslow and Bubnell I do hearby promise for me my heires executors
